This Price Plan Guide applies to the Vodafone Business Optimiser 2.0 price plan and is incorporated into the Commercial Terms between Vodafone and Customer and, together with the General Terms, Mobility Service Terms, Service Specific Terms, Order and any applicable policies and guidelines shall form the Agreement for the Vodafone Business Optimiser price plan.

All Charges detailed in this Price Plan Guide are Standard List Price and subject to change.

1. Tariff Structure

1.1 Business Optimiser 2.0 is a data self-optimising plan: The tariff will automatically move the Customer up the data ladder depending on their data usage in each billing cycle. This will make sure the Customer is paying the most cost-efficient price for the data being consumed on each connection. The Business Optimiser tariff will:

- (a) Start every month with 0mb data allowance (Step 0).
- (b) Each Connection automatically moves up the ladder as they use data.
- (c) Individual Capping and notifications options as customer moves up ladder. (See section 7.)

1.2 The Optimiser tariff consists of 2 options:

- (a) Optimiser Pro
 - (i) Voice & data plans
 - (ii) Data Only plans – voice service not enabled

Each connection starts from the bottom of the ladder each month and gets charged according to their data usage.

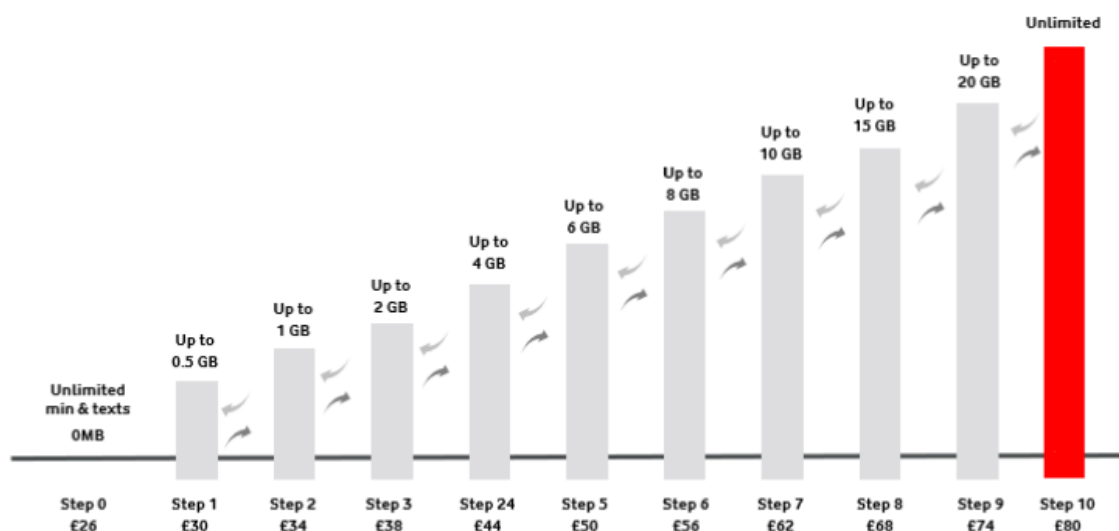

E.g., Step 1 is triggered when 50kb are used, Step 2 is triggered when 50kb are used above 512MB, Step 3 is triggered when 50kb are used above 1GB, Step 4 is triggered when 50kb are used above 2GB, and so forth.

1.4 Unlimited UK Minutes and Texts:

- (a) Each Voice & Data Connection on the Vodafone Business Optimiser 2.0 price plan has unlimited calls to UK mobiles and UK landlines (starting 01, 02, 03) and standard UK text messages made or sent (as applicable) from and to the UK.
- (b) All other call and text types on the Vodafone Business Optimiser 2.0 price plan shall be charged at the out of bundle rates set out in this Price Plan Guide.
- (c) Calls made through the return call service via voicemail are included in the Customer's allowance and will be charged 0p (Minimum call charge of a minute and then charged per second) for returning calls made to Vodafone UK mobile standard UK landline (starting 01, 02 or 03), and other UK mobile networks within the UK. All other calls using call service will be charged the Vodafone Business Optimiser 2.0 prices detailed in this guide.

1.5 Wi-Fi Calling:

- (a) Wi-Fi calling is available to Customer on Business Optimiser 2.0 Voice & Data plans whose Users have compatible devices.

1.7 5G:

1.8 Data

- (a) Business Optimiser 2.0 charges domestic data usage in optimising steps for each connection so the Customer is on the most cost-effective plan, refer to the Commercial Terms for the Optimiser Step pricing. The Customer can use the domestic Data in Business Traveller countries (subject to the daily charges set out below), Data usage outside of the Business Traveller countries is charged at roaming rates. Refer to the roaming section for more details.

1.9 Mobile data roaming FUP

- (a) On all Business Optimiser 2.0 plans, data usage, when roaming in the inclusive and Business Traveller destinations, will be capped at 25GB per billing month. Customers' will be notified as they approach this limit if they haven't opted out of notifications. If the limit is reached this limit, customer will be surcharged £2.05per 1GB (ex VAT) to continue using data in all the Inclusive and Business Traveller destinations until their monthly allowance renews

1.10 Inclusive International Calls & texts bundle

The International Calls & Texts bundles included in the Business Optimiser 2.0 Pro voice & data plans can be used for calls made and texts sent from the UK to the following destinations:

- (a) European Union, Channel Islands, Iceland, Isle of Man, Liechtenstein, Norway, Monaco, San Marino
- (b) If the customer calls or texts from the UK to a destination not included in his price plan bundle, additional charges will apply, which are detailed in this Price Plan Guide (section 2).

1.11 Roaming allowance:

Inclusive Roaming Destinations: Customers may use his domestic UK allowances at no extra cost in the Inclusive Roaming zones, depending on the price plan used, which are as follows:

- (a) Optimiser Essentials: Isle of Man, Iceland, Norway, Republic of Ireland
- (b) Optimiser Pro: European Union, Channel Islands, Iceland, Isle of Man, Liechtenstein & Norway
- (c) If the customer uses the roaming service in a destination not Inclusive in his price plan, additional charges will apply, which are detailed in this Price Plan Guide (section 3).

Without prejudice to the foregoing, and without limiting Vodafone's rights and remedies, if the Customer removes the restriction on making voice calls (whether directly or indirectly), Vodafone shall charge Customer 37.5p per minute for voice calls made from Data-only plans to UK mobile or standard landlines (starting 01, 02, or 03).

- (c) Customer will automatically opt out of the 50 Euro monthly spend limit for data in Europe Zone 1, Europe Zone 2 and World Zone countries, together with associated notifications, because Customer will be using the UK data allowance.
- (d) When roaming in our Europe Zone 1, Europe Zone 2 and World Zone, the Daily Fee will be triggered when a customer generates any voice, sms or data use from their connection.
- (e) The Daily Fee is charged on a per connection basis (where applicable) and will allow customers to access their domestic tariff allowance when roaming in Europe Zone 1, Europe Zone 2 and World Zone
- (f) Customers using Business Optimiser 2.0 Essentials plans may also opt into one of our Europe Zone 1 roaming passes that will grant access to their domestic tariff allowance while in Europe Zone 1. These passes can be added before you travel or while you are travelling by contacting Vodafone and will only be billed for when activated by any generated voice, sms or data use while in Europe Zone 1. Where Customer opts into purchasing a roaming pass, the £2.00 daily fee will not apply.
 - (A) 8 Day Europe Roaming Pass = £8 (£1 per day)
 - (B) 15 Day Europe Roaming Pass = £15 (£1 per day)
- (g) On all Business Optimiser 2.0 plans, data usage when roaming will be capped at 25GB per billing month in Europe Zone 1, Europe Zone 2, and World Zone destinations. Customer will be notified as they approach this limit unless they have opted out of notifications. If this limit is reached, additional usage will be surcharged £2.05 per 1GB (ex VAT) to continue using data in Europe Zone 1, Europe Zone 2, and World Zone destinations until the monthly allowance renews.

3.3 Other roaming options

(a) Roaming Discount:

Customer may also opt in to a Roaming Discount (as listed in section 6.4, **one discount only**). Roaming discounts only apply in Rest of World Zone 1 and Rest of World Zone 2 destinations.

(b) Roaming Data Bundle:

- (i) Customer has the option of choosing a 1GB **or** 2GB Roaming Data Bundle. Roaming Data Bundles only apply in Rest of World Zone 1 destinations.

(c) Roaming Data Cap:

- (i) Customer has the option of choosing a £200, £500, £750, £1,000, £1,250, £1,500 or £2,000 Roaming Data Cap with Opt in Options which apply in Rest of World Zone 1 which are not included in the Business Traveller Footprint and Rest of World Zone 2 destinations.
